Your Rights	All financial companies need to share customers' personal information to run their everyday business. We list below the reasons financial companies can share their customers' personal information; the reasons Abridge Partners chooses to share; and whether you can limit this sharing.

Definitions	
Everyday Business Purposes	The actions necessary by financial companies to run their business and manage customer accounts, such as providing investment advisory and financial planning advice, processing securities transactions, and otherwise providing financial services to you.
Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies. Abridge Partners has the following affiliates:</p> <ul style="list-style-type: none"> • Birgen Asset Management, Inc. • Business Prosperity, LLC
Non-Affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Abridge Partners does not share information with non-affiliates for marketing purposes.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Abridge Partners does not engage in joint marketing with non-affiliates.

Sharing Practices	
How often does Abridge Partners notify me about their practices?	We must notify you about our sharing practices when you become a client and each year while you are a client.
How does Abridge Partners protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Abridge Partners collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> • establish an investment advisory relationship • contract for financial planning services • open an account or deposit money with custodians • purchase or sell securities with executing broker-dealers <p>We also collect your personal information from others, such as custodians, broker-dealers, or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit sharing only for</p> <ul style="list-style-type: none"> • affiliates' everyday business purposes—information about your creditworthiness • affiliates to market to you • non-affiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>

The official record of your account is maintained by your broker-dealer or custodian. Thank you.
